PUBLIC HEARING ON THE TENTATIVE 2024 BUDGET

Mr. Justin Zollinger stated that no changes had been made to the 2024 Tentative budget since being adopted by the Board in September.

Debra Armstrong opened the public meeting.

No comments were received.

Debra Armstrong closed the public hearing at 6: 05 p.m.

Discussion on Tentative 2024 Budget

At the September board meeting, Mr. Zollinger was asked to do an analysis on whether or not it would be cost effective to bring janitorial services in-house. Mr. Zollinger presented his analysis and findings.

The current annual cost is \$50,125 for the buildings that are currently serviced by the cleaning contractor. The estimated time the contractor employees spend cleaning is 1,800 hours/year resulting in an equivalent hourly rate of \$27.85/hour. The hours are estimated to increase in 2024 to 3,600 hours/year due to the increase in building space and we have been told by the contractor to expect an increase of approximately \$60,000/year bringing the total contractor cost to \$110,000/year and equivalent rate to \$30.56/hour. To bring the cleaning in-house, CVWRF would need to hire two full-time employees at a cost of \$80,000/year including wages and all benefits which equals \$160,000/year or \$38.48/hour. Based on these projections, it makes best financial sense to continue with contracting out the cleaning services. Cleaning services will be rebid next year and if the costs are substantially different it is recommended that this analysis be revisited.
